The following features must be standard part of the kit and documentary evidence of the same should be provided along with technical bid.

Technical specification for Epinephrine/Norepinephrine/Dopamine ELISA Kit	
Regulation Status:	For research use only (RUO)
Kit requirement	Kit must be based on an enzyme immunoassay for the quantitative determination of Epinephrine, Norepinephrine and Dopamine in plasma and urine. Kit must contain three assay plates, for Epinephrine, Norepinephrine and Dopamine separately.
Calibration Range (approximate)	Adrenaline: 0.8 to 200 ng/mL urine, 20 to 6500pg/mL plasma Noradrenaline: 3 to 1000 ng/mL urine, 95 to 33000pg/mL plasma Dopamine: 5 to 2000 ng/mL urine, 75 to 33000pg/mL plasma
Limit of Detection	Adrenaline: 1 ng/mL urine, 10pg/mL plasma Noradrenaline: 2 ng/mL urine, 35pg/mL plasma Dopamine: 3 ng/mL urine, 45pg/mL plasma
Applications	Quantitative
Protocols	Written and printed protocol should be provided by the manufacturer.
Storage Instruction	Kit storage should be at 4°C.
Expiry date of the kit	Long term (6 months) from the date of delivery of kit.

Eligibility Criteria

- Bidder should be Manufacturer/ Authorized Partner/ Reseller of the manufacturer and a Letter of Authorization from manufacturer for the same and specific to the tender should also be enclosed.
- The Bidder shall provide the Registration number of the firm along with the LST/ CST/ WCT No. and the PAN Number issued by the concerned authorities.
- Separate technical and price bid should be uploaded.
- Technical Bid must contain a Technical Compliance sheet. Technical compliance sheet must have the page number of a published catalogue/experimental protocol/manufacture website as proof for compliance with the kit for each technical point. Relevant copies of catalogue/experimental protocol/manufacture website pages that have been listed as proof should be attached.
- The technical bid should mention the Expiry Date of the kit.
- Price Bids should contain the prices, terms of delivery, sales, payment terms etc., Other requirement, if any, for smooth experimental performance using the kit during expiry period to be quoted as an optional.
- The bidder must not be blacklisted by Delhi University. A Certificate or undertaking to this effect must be submitted.
