General terms and conditions governing the DBT – JRF fellowship are given below:

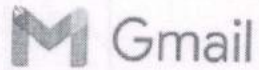
- 1. Admission to Ph.D. programme:** Fellowship is tenable at any Indian university/ institution where the selected candidate registers for Ph.D programme. Admission procedure will be as per the rules and regulations of the host university/ institution. While considering the fellowship award, scanned copy of the original documents related to the eligibility criteria and caste/category/others shall be submitted for further necessary action.
- 2. Activation of Fellowship:** Fellowship will be activated from the date of issuance of this award letter or from the date of joining the Ph.D programme, whichever is later. Validity of this award letter will be for two years from the date of issuance of the award letter, beyond which the validity of the award letter will lapse.
- 3. Tenure of Fellowship:** Total tenure of fellowship is for a period of five (5) years from the date of activation of fellowship. Duration of the fellowship is initially for a period of two (2) years from the date of joining. Fellowship may be extended maximum up to five (5) years depending on the satisfactory progress of the fellow and the completion of the Ph.D. programme.
- 4. Emoluments under Fellowship:** Fellow will be designated as "DBT-JRF" with consolidated fellowship of Rs. 31,000/- per month and a contingency grant of Rs. 30,000/- per year. If the fellow has not availed institutional hostel/ residential facility, fellow will be entitled for House Rent Allowance (HRA) as per DST guidelines applicable to research fellowships.
- 5. Release of Fellowship:** Fellowship, contingency and HRA (if applicable) will be released to the host university/institution upon timely submission of requisite documents.
- 6. Compliance with Guidelines:** Mere issuance of this award letter and activation of the fellowship does not guarantee the emoluments under the fellowship and this award will be subject to compliance to the DBT-JRF Programme Guidelines as applicable from time to time.

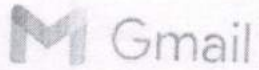
